O R D E R

In view of the orders passed in W.P.(C) No.713/2023 by this Court discussing the same very feature film and making comments on the merits, the film having now been released, we are of the view that all the proceedings relating to this film filed in different Courts is a futile exercise which must stand closed.

Thus, we consider it appropriate to close proceedings pending before different High Courts/Courts relating to the subject matter in the issue, the film having been released pursuant to a certification of the Competent Body constituted under the Cinematograph Act, 1952.

The aforesaid puts a closure to all the different proceedings pending in different Court.

The transfer petitions stand disposed of accordingly.

The directions passed in the impugned order dated 28.6.2023 in SLP (C) No.14520/2023 is set aside. The special leave petition also stands disposed of.
