**OFFICE REPORT**

The matters above mentioned were listed before Ld. Registrar Court on 10.02.2016, when the Court was pleased to pass the following order:-

**"The served respondents shall be at liberty to file the counter affidavit within a period of four weeks.**

**Fresh steps for the service of notice by usual mode to the unserved respondents shall be taken by the learned counsel for the petitioners within a period of four weeks. Dasti, in addition, is permitted to be served on the learned Advocate appearing before the court below.**

**List the matters on 01.04.2016."**

**SLP (C) NO.28386/2015**

It is submitted that M/s. Rishi Matoliya, Rajiv mehta & Avijit Bhattacharjee, Advocates have filed vakalatnama/appearance ob behalf of respondent Nos. 1 to 4, 7 and 11-12 respectively but they have not filed counter affidavit so far. Duly signed A.D. cards have been received in respect of respondent Nos. 5, 6, 8-10, 13, 20, 29 & 31. Unserved cover has been received in respect of respondent No. 24. Neither A.D. nor unserved cover has been received in respect of respondent Nos. 14 & 15 so far.

It is further submitted that counsel for the petitioner has filed affidavit of dasti service after serving respondent Nos. 16-19, 21-23, 25-28 and 30 but not for respondent Nos. 14, 15 & 24.

Service is not complete upon respondent Nos. 14, 15 & 24.

**SLP (C) NO. 28470/2015**

It is submitted that there are 31 respondents. Counsel appearing for Respondent Nos. 1 to 4, 7, 11 & 12 have not filed counter affidavit so far. Counsel for petitioner has not taken fresh steps to serve unserved respondent Nos. 8, 9, 15-18, 21, 23-31. However, she has on 29.03.2016 filed Affidavit of service in view of Ld. Registrar Court's Order dated 10.02.2016 duly serving respondent Nos. 9, 15, 17, 18, 21, 24, 26, 28, 29, 30 & 31 by Dasti process. In respect of respondent Nos. 6 & 8 it is stated in Affidavit of service that they are State respondents represented by standing counsel of Meghalaya but no one has entered appearance on behalf of State so far. Service of notice is not complete on respondent Nos. 6, 8, 16, 23, 25 & 27. Only two sets of spare copy with fresh address of respondent Nos. 25 & 27 have been filed.

**SLP (C) NO. 28480/2015**

It is submitted that there are 31 respondents. Counsel appearing for Respondent Nos. 1-4, 7 and 11 & 12 have not filed counter affidavit so far. Counsel for petitioner has on 28.03.2016 filed spare copies of SLP for issuance of fresh show cause notice to unserved respondent Nos. 16, 17, 18, 20-26 & 30 and notice has been issued on 30.03.2016 by usual mode and dasti mode. No one has entered appearance on behalf of rest of the served respondents.

**SLP (C) NO. 28519/2015**

It is submitted that there are 31 respondents. Counsel appearing for Respondent Nos. 3, 5 to 8, 11 & 12 have not filed counter affidavit so far. Fresh notice to unserved Respondent Nos. 1, 2, 10, 13-21, 23-24, 26-31 was issued on 21.03.2016 by usual mode as well as Dasti. Service by both modes is awaited. No one has entered appearance on behalf of rest of the served respondents.

**SLP (C) NO. 29379/2015**

It is submitted that there are 30 respondents. Counsel appearing for Respondent Nos. 1 to 4, 5 & 11 to 12 have not filed counter affidavit so far. Counsel for petitioner has not taken fresh steps to serve unserved Respondent Nos. 6, 13, 15-17, 22-26, 30 & 31 so far. No one has entered appearance on behalf of

rest of the served respondent.

Service is not complete on Respondent Nos. 6, 13, 15-17, 22-26, 30 & 31.

The matters above-mentioned are listed before Ld. Registrar Court with this Office Report.
