It is submitted that there are total 12 respondents
in the instant matter. Mr. Kamal Mohan Gupta, Advocate
(earlier Standing Counsel for State of Haryana) has filed
Vakalatnama / memo of Appearance and Counter Affidavit on
behalf of respondent Nos. 1 and 2. Mr. Ravindder Bana,
Advocate has filed Vakalatnama / memo of Appearance and
Counter Affidavit on behalf of respondent no. 3(HSIIDC).
Mr. R.P Goyal, Advocate has filed Vakalatnama / memo of
Appearance and Counter Affidavit on behalf of respondent
nos. 8 and 9. Mr. Neeraj Shekhar, Advocate has filed

Vakalatnama & memo of Appearance and Counter Affidavit on behalf of respondent No. 10. Copies of the Counter Affidavits have been included in the SLP paper books. Mr. S.S Khanduja, Advocate has on 31.8.2016 filed Vakalatnama and Memo of Appearance on behalf of respondent Nos. 12 and 6 after taking 'NOC' from erstwhile Advocate Mr. B.K Satija. He has also filed notification issued on 18.5.2011 by Govt. of India, Ministry of Corporate affairs wherein it is stated that the name of Sarvpriya Industries Limited (i.e. respondent No. 6) has been changed to Jindal Buildsys Limited but he has not filed application for change of Cause Title.

It is submitted that counsel for the petitioner has on 29.8.2016 filed common Rejoinder Affidavit alongwith Application for permission to place on record additional facts and documents as per court's order dated 26.7.2016 with the permission of Hon'ble Court . The said application is registered as I.A No. 5. Copy of the Rejoinder Affidavit and I.A No.5 is already included in SLP paper books.

It is also submitted that counsel for the petitioner has on 30.8.2016 filed Application for Direction in SLP (C) No. 2222/2012. The said application is registered as I.A No. 6 and is included in SLP paper books.

It is again submitted that Mr. Kamal Mohan Gupta is no more standing counsel for State of Haryana, but no one has entered appearance in his place so far.

It is submitted that Dr. Monika Gusain, counsel has on 3.10.2016 filed Vakalatnama & memo of Appearance on behalf of respondent No. 1 in place of Mr. K.M Gupta, Advocate but no Counter Affidavit has been filed so far.

It is further submitted that no one has entered appearance on behalf of respondent no. 2 though served through Dasti.
