O R D E R

SLP(C) No. 34917/2014

Service of notice is complete on respondent Nos. 1 to 5, 7 and 8 but no one has entered appearance on their behalf.

Last chance is given to Respondent No.6 to file counter affidavit within two weeks' time and thereafter the matter be processed for listing before Court under rules.

SLP(C) No. 34857/2014
