OFFICE REPORT

It is submitted that Mr. Vijay K. Jain, Advocate has filed Special Leave Petitions on 24.08.2016 against the Judgment and Order dated 05.02.2016 of the High Court of Punjab and Haryana at Chandigarh in RFA Nos. 6561-6564, 6566/2012, 4262, 4453, 5856, 5858, 6136, 6137, 6869/2013, 3739/2014, 5982, 5983 & 5984 of 2015 alongwith

application for permission to file Special Leave Petition, exemption from filing Official Translation and application for deletion of the names of performas Respondent Nos. 5-8 in RFA No. 3739/2014.

It is further submitted that Counsel for petitioner has also filed an application for substitution to bring on record the LRs of deceased petitioner no. 5 namely Jile Singh in RFA No. 5858/2013 and petitioner no. 1 namely Ram Pal in RFA No. 6869/2013 which is barred by time by 2841 and 1108 days and Counsel has also filed an application for condonation of delay in filing substitution application alongwith setting aside abatement.

It is further submitted that Special Leave Petition filed against the Judgment and Order dated 05.02.2016 in RFA Nos. 6561-6564, 6566/2012, 4453, 5856, 5858, 6136, 6137, 6869/2013, 3739/2014, 5982, 5983 & 5984 of 2015 is barred by time by 111 days and 30 days in RFA NO. 4262/2013, Counsel for the petitioner has filed applications for condonation of delay in filing the SLP.

It is further submitted that the instant matters are tagged with CC Nos. 20036-20037 of 2016 Entitled Beena Yadav & Ors. Etc. Versus State of Haryana & Ors. Etc. etc. as both are arising out of common followed Judgment.

It is further submitted that Counsel for the petitioner has filed a letter dated 04.10.2016 (at page no. 154 in the Paper Books) stating therein that notification dated 11.01.2005, awards dated 27.02.2012 and 10.05.2006 and exhibits mentioned in the judgment are not necessary for adjudication of the present matter and has undertaken to file the same as and when required by the Hon'ble Court. Counsel has requested to ignore the defects and list the matter at his own risk.

The matters are listed before the Hon'ble Court with this office report.
