The matters above mentioned were listed before the Registrar Court on 26.08.2016, when the following Order was passed:

"SLP(C) No.5586/2016

Fresh steps for the service of notice by usual mode to the unserved respondent Nos.9 & 11 shall be taken by the Ld.counsel for the petitioner within a period of three weeks. Dasti in addition is permitted to be served through the concerned Trial Court, the particulars of which shall be furnished by the Ld.counsel for the petitioner within the period provided above.

SLP(C) No.13946/2016

Four weeks time as last chance is given to the respondent No.6 to file the counter affidavit.

Fresh steps for the service of notice by usual mode to the unserved respondent Nos.4 & 7 shall be taken by the Ld.counsel for the petitioner within a period of three weeks. Dasti in addition is permitted to be served through the concerned Trial Court, the particulars of which shall be furnished by the Ld.counsel for the petitioner within the period provided above.

In respect of the respondent No.5 service is deemed complete as he is appearing as petitioner in the connected SLP(C) No.5586/2016.

Await the return of the service of notice already issued to the respondent No.2.

List the matter again on 05.10.2016."

SLP(C) No. 5586 of 2016

It is submitted that counsel for the petitioner has filed two sets spare copies of SLP, but he has not furnished the particulars of the concerned Trial Court. Therefore, show cause notice to unserved respondent nos. 9 & 11 could not be issued.

Service of show cause notice on respondent nos. 9 & 11 is not complete.

SLP(C) No. 13946 of 2016

It is submitted that counsel for respondent no. 6 has not filed counter affidavit so far.

It is further submitted that unserved envelope has been received back from respondent no. 2 with the Postal Remarks "Party Left" return to sender.

It is further submitted that in respect of unserved respondent nos. 4 & 7 counsel for the petitioner has on 31.08.2016 filed one set of spare copy of SLP alongwith letter dated 29.08.2016 (copy enclosed), stating therein that respondent no. 7 is the State of Karnataka and he has served a copy of the pleading to the Standing Counsel for the State of Karnataka. Counsel has filed proof of service. Hence, service of show cause notice on respondent no. 7 may be treated as complete. In respect of respondent no. 4 show cause notice was issued on 20.09.2016. As per Tracking Report "Item Delivered" (Tracking Report is enclosed herewith). Hence service of show cause notice on respondent no. 4 is complete.

Service of show cause notice on respondent no. 2 is not complete.
