O R D E R

1. Inviting attention of this Court to the copy of the order by the High Court dated 27.07.2023 the same is annexed to the application as Annexure-A1 at page No.5. A perusal of the order of the High

Court reveals that Respondent Nos.1, 2 and 4 namely B. Balamma, K. Jaya Ramudu and M. Anasuyamma expired during the pendency of Land Grabbing Appeal No.4 of 2017 and Respondent No.5 to 7 namely K. Nagalatha, K. Madhu Sudhan and K. Mounika were added as legal heirs of Respondent No.2 as per order dated 21.08.2014 in IA No.513 of 2014.

2. Accordingly, the IA No.18067 of 2025 is allowed in terms of prayer 'B'.

3. Ms.Megha Shaw, learned counsel accepts notice on behalf of Respondent No.1 and prays that she has instructions to appear for Respondent No.1 and prays two weeks' time to file Vakalatnama.

4. Two weeks time is granted for filing Vakalatnama by Respondent No.1.
