OFFICE REPORT

It is submitted that the above mentioned Special Leave Petition is filed by Mr. Kuldip Singh, Advocate on 14.03.2015 against the Judgment and Order dated 27.08.2013 of the High Court of Punjab and Haryana at Chandigarh in RFA No. 583, 783-786, 835-845 of 1997, 195-197, 201-202 of 1998 and 3079 of 1999 (O & M).

It is further submitted that Counsel for the petitioner has filed **two applications** for condonation of delay in filing the SLP and refiling the SLP (i) there is a delay of 474 days in filing the SLP (ii) a delay of 102 days in refiling the SLP. There is a total delay of 576 days in filing and refiling the SLP.

It is further submitted that SLP (C) CC No. 12871 of 2015 Entitled Madhi & Ors. Versus State of Punjab & Ors. arising out of common followed Judgment is a fresh matter and to be listed along with SLP (C) Nos. 17574-17580 of 2015 as per order dated 14.08.2015. SLP is pending (Copy of order dated 14.08.2015 is enclosed herewith).

It is further submitted that **notice** in SLP (C) Nos.17574-17580 of 2015 @ CC Nos. 9008-9013 of 2015 Entitled Jaswant Singh & Ors. Etc. Versus State of Punjab & Ors. Etc. arising out of common relied upon Judgment was directed on 01.07.2015 by Hon'ble Court. SLP is pending after notice (Copy of order dated 01.07.2015 is enclosed herewith).

It is further submitted that Mr. Kuldip Singh, counsel for the petitioner has on 05.08.2015 filed documents i.e. Notification dated 02.12.1992 as per his undertaking letter dated 13.05.2015 and the same is being circulated with this office report.

The matter is listed before the Hon'ble Court with this office report.
