Accordingly, notice was issued to Respondent No. 1 through Ministry of Law & Justice on 18-04-2015 and on Respondent Nos. 2 to 6 through Regd A.D. Post on 12-06-2015.

It is submitted that M/s. K.J. John & Co has on 24-02-2015 filed Caveat alongwith Vakalatnama & memo of appearance on behalf of Respondent No. 2 and M/s Parekh & Co has on 26-06-2015 filed Vakalatnama and memo of appearance on behalf of Respondent No. 1.

unserved Cover of the said notice have been received back from Respondent Nos. 3 to 6.

It is also submitted that the counsel for the petitioner has on 05-06-2015 filed two applications (i) For impleadment as party Respondent No. 11 and (ii) For injunction & stay which have been registered as Interlocutory Application NO. 3 and No. 4 respectively and has on 19-06-2015 filed further Affidavit of the Applicants after serving its copies on the other side.
