O R D E R

Heard the learned senior counsel for the petitioner, learned senior counsel for the respondent-State as also the learned counsel for the petitioner in W.P. No. 25522/2022 before the High Court, who has filed his objections to the instant petition.

Though, in the instant petition, the petitioner has sought for de-tagging the W.P. No. 25522/2022 from the W.P. No. 11803/2022 pending before the High Court of Calcutta, we, at this juncture, see no reason to exercise our discretion under Article 32 of the Constitution since such relief should be sought before the High court in the pending petitions.

Be that as it may, we note that the High Court, through its Order dated 10.05.2023, has listed both the petitions along with the applications for consideration on 26.06.2023 at 02:00 p.m. as an assigned matter. We hope that the petitions would be taken up for consideration by the High Court and all the parties would co-operate for early disposal of the matters. All contentions of the parties are left open to be urged before the High Court in accordance with law.

Petition is accordingly, disposed of in the above terms along with the pending application(s), if any.
