#### OFFICE REPORT

The Special Leave Petitions above-mentioned have been filed against the Judgment and order dated 23<sup>rd</sup> December, 2015 of the High Court of Judicature, at Hyderabad for the State of Telangana and State of Andhra Pradesh in W.A. No. 343 of 2015.
