O R D E R

SLP(C) No. 24356/2023 and SLP(C) No. 24357/2023

Despite service being complete, none has entered appearance for respondent nos.2 and 3.

As per office report service is complete on respondent no.1. Mr. Fateh Singh, Ld. Counsel appearing for Mr. Samar Vijay Singh, Ld. AOR has entered into appearance on behalf of respondent no.1. Four weeks time, is granted to file vakalatnama as well as counter affidavit.

Two weeks time, as a last opportunity has already been granted to Ld. Counsel for the petitioner on 13.05.2025 to take fresh steps and to file fresh particulars for effecting service upon respondent no.4.

Four weeks time, is granted to all appearing respondents to file counter affidavit.

Two weeks time, is granted to Ld. counsel for petitioner, to take fresh steps to issue notice to all unserved respondents.
