“Mr. S.N. Bhat, Adv. has instructions to appear on behalf of respondent no. 1. Ms. Vijayanthi Girish, Adv. appears on behalf of respondent nos. 2 and 3 in SLP(C) Nos. 30374-30375/2014.

Counter affidavit be filed within two weeks.

Rejoinder affidavit be filed within two weeks thereafter.

List the matters on 24th July, 2015.

Ad-interim relief with regard to dispossession shall continue.

Issue fresh notice by speed post to respondent no. 4 in SLP(C) Nos. 30374-30375/2014.

Respondent no.4 shall file counter affidavit on notice upon him by that time.”

It is submitted that Mrs. Vijayanthi Girish, Advocate has already filed statement of counter on behalf of respondent Nos. 2 & 3 who are Respondent Nos. 3 & 4 in SLP 30375/2014 and has on 07.05.2015 filed corrected affidavit with the leave of Hon'ble court in support of counter affidavit but no vakalat/appearance have been filed on behalf of respondent nos. 2 & 3 in both SLPs. Copies of the same have been included in the paper books and Mr. S.N.Bhat, Advocate has not filed counter

affidavit on behalf of common Respondent no. 1 so far. Hence no rejoinder affidavit filed. Mrs. Vijayanthi Girish, Advocate though appeared on behalf of Respondent No. 2 in SLP 30375/2014 but no vakalat/appearance. Hence, no counter affidavit filed.

It is further submitted that show cause notice was issued to common Respondent Nos. 4(a) to 4(c) through speed post. Same has been delivered on all the Respondent Nos. 4(a) to 4(c) on 25.05.15 but no appearance hence no counter affidavit filed.

SLP NO(S). 2451-52/2015

It is submitted that Ms. Anjana Chandrashekar, Advocate has on 07.05.2015 filed corrected affidavit with the leave of Hon'ble Court in support of counter affidavit filed on 17.02.2015 on behalf of Respondent No. 3 and the same has been included in the paper books. She has also not filed vakalatnama/appearance with respect of Respondent No. 3 in SLP(c) NO. 2451-52/15.
