OFFICE REPORT

It is submitted that the above mentioned Special Leave Petition is filed by Mr. Devesh Kumar Tripathi, Advocate on 26.11.2015 against the Judgment and Order dated 08.07.2015 of the High Court of Punjab and Haryana at Chandigarh in RFA No. 5128 & 5129 of 2010.

It is further submitted that Counsel for the petitioner has filed two applications for condonation of delay in filing the SLP and refiling the SLP (i) there is a delay of 42 days in filing the SLP (ii) a delay of 70 days in refiling the SLP. There is a total delay of 112 days in filing and refiling the SLP.

It is further submitted that notice in SLP (C) No.12018-12019 of 2016 @ CC Nos. 21961-62/2015 Entitled Narinder Singh & Ors. Etc. Etc. Versus State of Haryana & Ors. Etc. Etc arising out of common relied upon Judgment was directed by the Hon'ble Court on 08.04.2016. SLP is pending after notice (Copy of order dated 08.04.2016 is enclosed herewith).

It is further submitted that notice in SLP (C) Nos. 16427-16437 of 2016 @ CC Nos. 9129-9139 of 2016 Entitled Harpreet Kaur Etc. Etc. Versus State of Haryana & Ors. Etc. arising out of common order was directed by the Hon'ble Court on 29.06.2016. SLP is pending (Copy of order dated 29.06.2016 is enclosed herewith).

It is further submitted that Counsel for the petitioner has not furnished copy of document/sale deed dated 12.10.2012 as per his undertaking letter dated 04.03.2016. In this regard, Counsel has given a letter dated 09.07.2016 stating therein that the same is not available and also not necessary and has asked to place the matter for hearing before the Hon'ble Court.

The matter is listed before the Hon'ble Court with this office report.
