**OFFICE REPORT**

The Office Report was listed before the Ld. Registrar's Court on 10<sup>th</sup> August, 2016 when the following orders were passed:-

**“SLP(C) Nos.30593-30594/2015 and 11771/2016**

The sole respondent has failed to file the counter affidavit within the period stipulated under the rules in both matters. Viewed thus, the matters shall be processed for listing before the Hon'ble Court as per rules.

**SLP(C) Nos.394, 6773, 10127, 11154/2016 & 35257/2015**

Being complete matters, list the same before the Hon'ble Court as per rules.

**SLP(C) No.392/2016**

Four weeks time as last chance is given to the Ld.counsel for the petitioner to file the fresh particulars and to take fresh steps for the service of notice to the unserved sole respondent.

**SLP(C) No.395/2016**

Four weeks time as last chance is given to the Ld.counsel for the petitioner to take fresh steps for the service of notice to the unserved respondent No.2.

**SLP(C) No.389/2016**

Four weeks time as last chance is given to the Ld.counsel for the petitioner to take fresh steps for the service of notice to the unserved sole respondent.

SLP(C) No.1232, 7559, 11156, 10126,11772, 11145, 11769, 12787 & 14547/2016

The name of the sole respondent has been changed. Ld.counsel for the petitioner is directed to file an I.A. for amendment of cause title within four weeks in all the matters.

SLP(C) No. 6735-6740/2016

Await the return of the service of notice already issued to the sole respondent.

SLP(C) No.9473/2016

Ld.counsel for the petitioner shall within a period of four weeks file the affidavit in proof of dasti service of notice already issued to respondent No.1.

The name of respondent No.2 has been changed. Ld.counsel for the petitioner is directed to file an I.A. for amendment of cause title within four weeks.

List the matter again on 22.09.2016.”

SLP (C) NO. 392 OF 2016

It is submitted that unserved cover containing Fresh Show Cause Notice has been returned with postal remarks “LEFT WITHOUT INSTRUCTIONS” as per report of postal authorities.

SLP (C) NO. 395 OF 2016

It is submitted that Fresh Show Cause Notice has been issued to the Respondent No.2 through Registered A.D. Post on 3<sup>rd</sup> September 2016. Service of Notice is awaited.

SLP (C) NO. 389 OF 2016

It is submitted that fresh show cause notice issued on 3<sup>rd</sup> September 2016 to the Sole Respodnent through Registered A.D. Post, has returned unserved as per report of Postal Authorities.

SLP(C) No.1232/2016

It is submitted that Counsel for the Respondent has not filed Counter Affidavit so far.
