UPON hearing the counsel the Court made the following O R D E R

We have perused the last order dated 18th November, 2024. In terms of the last order, a compliance affidavit dated 24th December, 2024 has been filed by the first respondent/Municipal Corporation. Again in the compliance affidavit, there is not even a reference to the date and other particulars of the sanctioned plan of the building in question on the basis of which an opinion was formed by the officials of the Municipal Corporation. Perhaps, the first respondent/Municipal Corporation has not understood the meaning of the simple orders passed by this Court. The entire emphasis was that the Municipal Corporation must examine the sanctioned plan and in the context of the sanctioned plan, the Municipal Corporation must find out whether all the illegal extensions/constructions have been removed in terms of the undertakings given by the petitioners.

We direct the Commissioner of the first respondent/Bidhannagar Municipal Corporation to remain present before this Court through video conference on the next date.

List the Petitions on 7th February, 2025.

In the meanwhile, it will be open for the first respondent/Municipal Corporation to make proper compliance with the order of this Court.
