**OFFICE REPORT**

The Special Leave Petition above-mentioned has been filed against the Judgment and Order dated 25<sup>th</sup> August, 2014 of the High Court of Judicature, Hyderabad for the State of Telangana and the State of Andhra Pradesh in CMA No. 386 of 2014.

It is submitted to the Hon'ble Court that two applications for condonation of delay have been filed i.e. one is for condonation of delay in filing Special Leave Petition and another in refiling the Special Leave Petition. There is a delay of 25 days in filing the Special Leave Petition and 03 days in refiling the Special Leave Petition. The total delay is of 28 days.
