**OFFICE REPORT**

The matter above-mentioned was listed before the Ld. Registrar's Court on 26.02.2016 when he was pleased to pass the following order:-

*"Two weeks time is granted for taking fresh steps for service of respondent nos. 2, 7-11, 19-21, 23, 25, 26, 30, 32, 34-36, 38, 39, 43 and 45. Notice be issued thereafter.*

*Two weeks time, as last opportunity is granted for taking fresh steps for service of respondent nos. 13-18, 22, 24, 33, 40, 46, 47, 50 and 51. Notice be issued thereafter.*

*Despite last opportunity having been granted respondent nos. 1, 3-6, 27-29 and 12 have not filed counter affidavit, as such, further opportunity is declined.*

*Respondent no. 37 to file counter affidavit within four weeks time.*

*List again on 11.05.2016."*

It is submitted that counsel for the petitioner has on 14.3.2016 filed spare copies alongwith fresh address of Respondent Nos. 13-18, 22, 24, 33, 40, 45, 47, 50, 51.

Accordingly show-cause notice was issued on 17.3.2016 to Respondent Nos. 2, 7-11, 19-21, 23, 25, 26, 30, 32, 34-36, 38-39, 43, 45 and at fresh address of Respondent Nos. 13-18, 22, 24, 33, 40, 46, 47, 50 and 51. Unserved envelope from Respondent No.25 has been received back with remarks 'refused'. Neither AD card nor unserved

cover containing show-cause notice from Respondent Nos. 2, 7-11, 13-24, 26, 30, 32-36, 38-40, 43, 45-47, 50, 51 have been received back and service is yet awaited.

Service on remaining respondents is complete but counsel for Respondent Nos. 1, 3-6, 27-28, 12 and 37 have not filed the counter-affidavit, so far.

The matter above-mentioned is listed before the Ld. Registrar's Court with this Office report.
