OFFICE REPORT

The Transfer Petitions above mentioned were listed before the Hon'ble Court on 16th December 2016, when the Court was pleased to pass the following Order:-

Accordingly, we issue notice in the respective Transfer Petitions and by way of interim direction, stay the further proceedings of the Writ Petitions/proceedings in the concerned High Court.

TRANSFER PETITION (CIVIL) NOS. 2018 -2022 OF 2016

It is submitted that there are thirty three respondents in this matter.

It is further submitted that Ld. Counsel for the Petitioner has on 22nd December, 2016 filed only five spare copies of the transfer petition with a result show cause notice as well as stay could not be issued so far.

It is also submitted that Ld. Counsel for the Petitioner has not supplied the two complete set of TP Paper Books in the matters above-mentioned.Contd...2/-

TRANSFER PETITION (CIVIL) NOS. 2030 -2038 OF 2016

It is submitted that there are fifty four respondents in this matter.

It is further submitted that Ld. Counsel for the Petitioner has on 22nd December, 2016 filed only nine spare copies of the transfer petition with a result show cause notice as well as stay could not be issued so far.

It is also submitted that Ld. Counsel for the Petitioner has not supplied the two complete set of TP Paper Books in the matters above-mentioned.

Thereafter, the matters above-mentioned were listed before the Ld. Registrar Court from time to time and on 7th March 2017, when the following Order was passed :-

"There are 33 respondents in T.P.(C) Nos. 2018-2022 and 54 respondents in T.P.(C) Nos. 2030-2038 but Ld. Counsel for the petitioners has filed five spare copies only in T.P.(C) Nos. 2018-2022/2016 and nine spare copies in T.P.(C) Nos. 2030-2038/2016. Ld. Counsel shall within a period of two weeks, as last chance file deficit spare copies for issuance of notice and in addition to that shall file two extra sets of paper book as the matter is referred to Constitution Bench.

List again on 21.4.2017."

It is submitted that Ld. Counsel for the Petitioners has not filed the deficit spare copies of the Transfer Petitions in the matters above-mentioned with a result show cause notice on the respondents through the concerned High Court as well as stay could not be issued.

It is further submitted that Ld. Counsel for the Petitioners has not supplied the two extra complete set of TP Paper Books in the matters above-mentioned as well as in the connected matters i.e. **T.P. (C) Nos. 1958-1967 of 2016 and 1982-1996 of 2016**, as the matters are referred to the Constitution Bench.

The matters above-mentioned are listed before the Court of Ld. Registrar with this office report.
