Fresh matter.

SLP(C) Nos. 18644-18647/2022

Four weeks time, is granted to respondent nos. 1 to 3 to file
counter affidavit.

Despite due service, none appears on behalf of respondent nos.
4 to 8.

Hence, process the matter for listing before the Hon'ble
Court, as per rules.

Four weeks time, is granted to respondent nos. 1 to 3 to file
counter affidavit.

Despite due service, none appears on behalf of respondent nos.
4, 7 and 8.

Service of notice is not complete upon respondent nos. 5 and
