The respondent was granted Career Advancement Scheme benefits by the learned Single Judge through his order dated 16.01.2015. The State's appeal to challenge the said verdict was delayed by 822 days. Noticing the subsequent events pursuant to the Single judge's order and the inordinate delay, the Division Bench refused to entertain the special appeal and the same was accordingly dismissed by the impugned order.

We have considered the basis of the impugned judgment and see no reason to interfere with the same. The Appeal accordingly stands dismissed.

As the State's appeal was dismissed on the ground of delay and we have upheld the dismissal order by the Division Bench, question of law, if any, is kept open.
