UPON hearing the counsel the Court made the following
O R D E R

Ld. Advocate, Ms. Shiva Vijaya Kumar, appearing on behalf of Mr. G. Balaji, Advocate-on-record appears for respondent Nos. 1 and 3 in both the matters. She seeks time to file vakalatnama and counter affidavit. Be filed within four weeks.

Ld. Advocate, Ms. Jyoti Parasher, appearing on behalf of Mr. S. Rajappa, Advocate-on-record appears for respondent No. 4 in both the matters. He seeks time to file vakalatnama and counter affidavit. Be filed within four weeks. Ld. Counsel for respondent No. 4 requested for complete set of pleadings.

Ld. Counsel for the petitioner is directed to serve complete set of pleadings within one week after filing vakalatnama and file proof thereof. Period of four weeks for filing counter affidavit shall reckon thereafter.

Ld. Advocate-on-record, Ms. Jaikriti S. Jadeja submits that respondent Nos.2, 7, 8, 16 and 18 in SLP(C) No. 102/2019 are respondent Nos.2, 7, 15 and 17 in SLP(C) No. 33088/2018 and Ld. Advocate-on-record, Mr.Pai Amit submits that respondent Nos.6 and 17 in SLP(C) No.102/2019 are respondent No.16 in SLP(C) No. 33088/2018 (respondent No.17 in SLP(C) No.102/2019). They submit that being common respondents, they would tender a letter mentioning therein that vakalatnama in one matter be treated as vakalatnama in the main matter for the same respondents. However, they are advised to file vakalatnama separately. They will do so within four weeks alongwith the counter affidavit.
