prays for and is/are granted permission to withdraw the matter(s). Hence, the instant matter(s) is/are dismissed as withdrawn.

Diary No. 46219-2023(Item No.2020)

Learned counsel for the petitioner(s) states that he will cure the defects in the matter within two weeks. If the petitioner(s) cure the defects, let the matter(s) be processed in accordance with the Rules. If the defects are not cured, the matter(s) be processed before the Chamber Judge.

Diary No. 45595/2023(Item No.1983)

Mr. T. Harish Kumar, learned counsel for the petitioner(s) states that Diary No.45595/2023 titled as "Priya & Anr. vs. The New India Assurance Co.Ltd.& Ors.", is a duplicate entry.
