The contention raised in these Interlocutory Applications is that some of the assesseees have not deposited the balance principal amounts. The amounts which according to the State are due and payable towards the principal amount are also set out. The concerned assesseees shall file counter affidavits setting out whether balance principal amounts have been paid. If they have paid the balance principal amounts, they shall produce evidence by annexing necessary documents. If the balance principal amounts have not been paid, they shall do so within a period of one month from today.

We grant leave in all the Special Leave Petitions.

If the balance principal amounts are not paid by the assesseees, we grant liberty to the State to move the pending applications.

The pleadings in the Appeals shall be completed by the end of July, 2024.
