O R D E R

D. NO. 26658/2021

Despite service of notice on respondent Nos. 1 to 6, 11 to 15, 22, 23, 25, 26, there is no appearance on their behalf.

However Mr. Amrish Kumar, Ld. Advocate has appeared on behalf of respondent No.3.

He seeks and is granted four weeks time to file vakalatnama and counter affidavit.

Petitioner has failed to file fresh particulars and to take fresh steps to effect service on respondent Nos. 8, 10, 16, and 17 to 21 and also failed to file application for substitution in respect of respondent Nos. 7, 9 and 24, though last chance was granted.

At this stage, Ld. Counsel for petitioner submits that he will file application for deletion in respect of respondent Nos. 7, 9 and 24. Ld. Counsel seeks and is granted two weeks time as a final opportunity to do the needful, failing which the matter shall be processed for listing before the Hon'ble Judge-in-Chambers for further directions.
