Special Leave Petition (Crl.) No.15816/2023 (Item No.46) and
 Special Leave Petition (Crl.) No.15817/2023 (Item No.46.1) :-

1. Heard learned Senior counsels for the petitioners and perused the material placed on record.

2. Since other petitioners in the connected Special Leave Petitions have already been granted exemption from surrendering till next date and since the present petitioners are in jail, they are directed to be released on bail on the terms and conditions that may be imposed by the Trial Court.

7. In rest of the matters, where exemption from surrendering has already been granted, the same shall continue to operate till the next date of hearing.
