UPON hearing the counsel the Court made the following
O R D E R

Respondent No.1 in SLP(C) No. 25385-25390/2023 and SLP(C) No. 2508/2024 and respondent No.5 in SLP(C) No. 27252-27256/2023 are granted four weeks' time for filing counter affidavit.

Respondent No.2 in SLP(C) No. 2508/2024 has filed vakalatnama but it is defective. Four weeks' time is granted for curing the defects in the vakalatnama and filing counter affidavit.
