Court under Article 139A of the Constitution of India as the issues involved herein are substantially the same as are pending before the Apex Court.

Learned counsel for the writ petitioners/respondents submits that Civil Appeal No.9198-9199 of 2018 are posted for final hearing on 20.03.2025.
