**JUDGMENT & ORDER (ORAL)**

Heard Mr. S.S. Dey, learned Advocate General, Mr. Kohinoor N. Bhattacharjee, learned G.A, Mr. D. Sarma, learned Addl. GA, Mr. M. Debbarma, learned Addl. G.A, Ms. A. Chakraborty, learned counsel and Mr. P. Saha, learned counsel appearing for the State-appellants as well as Mr. P. Roy Barman, learned senior counsel, Mr. Somik Deb, learned senior counsel assisted by Mr. S. Bhattacharjee, learned counsel, Mr. K. Nath, learned counsel, Ms. R.

Chakraborty, learned counsel and Mr. P. Chakraborty, learned counsel appearing for the writ petitioner in these matters respectively.

[2] The background in which the present batch of writ appeals and writ petition have come before this court needs to be referred in brief at the outset before dealing with the issue involved herein.

In the State of Tripura, the appointment of 10323 teachers were set aside by the judgment rendered by the Division Bench of this Court in the case of **Tanmoy Nath & others vs. State of Tripura & others**, reported in (2014) 2 TLR 731. The Court proceeded to issue a set of directions which included a direction upon the State to complete a fresh process of selection of teachers in all categories on or before 31<sup>st</sup> December, 2014; to frame a new Employment Policy within a period two months and carry out the selections in accordance with the fresh policy as early as possible and not later than 31<sup>st</sup> December, 2014. The learned court also issued directions giving the outline of the manner in which such guidelines have to be framed at Para-124 of the Judgment. The directions contained in Para-125 of the judgment are the basis for the present batch of litigations as these writ petitioners-respondents have been re-employed in a fresh recruitment exercise to fill up the different post of teachers. The advertisements were issued and the recruitment process was initiated before 31<sup>st</sup> March, 2020. Para-125 of **Tanmoy Nath** (*supra*) reads as under:

**“125. We would also like to make it clear that other than the benefits indicated by us above there can be no reservation/preference on the basis of age. There shall be no preference to dependent government servants or retired government employee or retrenched employees etc. There can be no reservation for linguistic or religious minorities or on area wise basis. It is further made clear that if the persons who are selected in the previous selection are again selected then the service rendered by them earlier shall be counted for the purpose of seniority, pension and all other purposes.”**

[3] It is pertinent to mention here that the judgment of **Tanmoy Nath** (*supra*) was taken in an appeal before the Apex Court. The Apex Court modified the directions contained in Para-123 of the impugned judgment in the following manner while disposing the Writ Appeals by judgment dated 29<sup>th</sup> March, 2017:

**“Since we do not find any ground to interfere with the impugned order, the directions in para 123 now required to be suitably modified. We, therefore, direct:**

**(a) New Employment Policy should be framed by the State by 30<sup>th</sup> April, 2017 if not already framed and advertisements for filling up the vacancies may be issued latest by 31<sup>st</sup> May, 2017.**

**(b) The fresh selection process be completed on or before 31<sup>st</sup> December, 2017 and till the fresh process is completed, the teachers already appointed shall continue.**

**(c) The candidates who participated in the selection process pursuant to the advertisements in question, whether selected or not, will be allowed to participate in the fresh selection process by relaxing their age but subject to their having necessary qualifications.**

**(d) The qualifications in the case of teachers governed by the provisions of the Right of Children to Free and Compulsory Education Act, 2009 shall be in conformity with the relevant statutory provisions of the said Act.**

**(e) The qualifications of teachers employed for Classes IX and above shall be strictly in compliance with the relevant provisions concerning such appointments.**

**Subject to the aforesaid modifications, the view taken by the High Court in the impugned order is affirmed and the special leave petitions are dismissed.**

**Pending application(s), if any, also stand disposed of.”**

[4] The Apex Court disposed of the appeal of the State Government finally by the order dated 29<sup>th</sup> March, 2017. The State took extensions for extending the adhoc appointment of the terminated teachers beyond 31<sup>st</sup> December, 2017 by filing interlocutory application before the Apex Court. The last extension was granted vide order dated 2<sup>nd</sup> August, 2017 in a Contempt Petition (C) No.1706/2017 filed in SLP(C) Nos. 18993-19049/ 2014 which is also extracted hereunder:

“On 01.11.2018, this Court permitted State of Tripura to avail services of terminated teachers until the end of the Academic Session 2019-2020. The observations in that behalf were as under:

‘..... Having considered the matter, we are of the view that at this stage, we ought to permit the State of Tripura to continue to avail of the services of the terminated teachers until the end of the academic session 2020, meaning the academic session 2019-2020. The above direction has been issued in the peculiar facts of the case and the circumstances which have confronted the State of Tripura and above all, the need to functioning of teaching activities in schools in the State of Tripura remains unaffected. ....’

The affidavit reporting compliance has since then been filed on 24.04.2019 indicating various steps taken and endeavours made by the State.

In view of the affidavit, nothing further need be done in the matter. This Contempt Petition is closed.”

[5] It is an accepted fact that adhoc services of the teachers which got extended beyond 31<sup>st</sup> December, 2017 got terminated w.e.f. 31<sup>st</sup> March, 2020 [afternoon] by the Government of Tripura. Be it also indicated here that in a decision rendered in connection with the same matter relating to termination of the teachers in the case of **Ajoy Debbarma & others vs. State of Tripura and others** [(2020) 8 SCC 67] it has been taken note of at Para-8 of the judgment that by the end of Academic Session 2019-2020, 8,882 adhoc teachers were working in the School Education Department in terms of the directions issued in **Tanmoy Nath** (*supra*) and by the Apex Court. The services of the concerned teachers stood terminated after the Academic Session 2019-2020. Several teachers who got reemployment prior to 31<sup>st</sup> March, 2020 approached this Court for counting of their past services as per Para-125 of the judgment in **Tanmoy Nath** (*supra*) as affirmed by the Apex Court. That set of writ petitions was heard and decided by the learned Single Judge of this Court presided by Hon’ble the then Chief Justice vide judgment dated 29<sup>th</sup> January, 2020 in the case of **Smt. Sangita Reang and others vs. The state of Tripura and others** [WP(C)]

**No.295 of 2019 & others]**. Learned Court in the said case has taken note in Para-6 of the judgment that the writ petitioners had applied afresh for selection and appointment pursuant to advertisements in different categories for which they were qualified after obtaining proper permissions from the employer. A common advertisement was issued on 27<sup>th</sup> May, 2017 for selection of the notified vacancies for the posts of Graduate as well as Post Graduate Teachers. A similar but separate advertisement was also issued on 27<sup>th</sup> May, 2017 inviting candidates to apply for the post of Under Graduate Teachers for filling up the number of notified vacancies. All those petitioners were selected and appointed pursuant to such selection process in different categories. Such appointment orders were issued in the year 2017-2018 and they had been working on such post since then.

[6] The issue involved in those batch of writ petitions led by the case of **Smt. Sangita Reang and others vs. The state of Tripura and others** [judgment and order dated 29.01.2020 in W.P.(C) No.295 of 2019 and others] was regarding the claim for benefit of past services in the light of Para-125 of the decision in **Tanmoy Nath** (*supra*). Learned Writ Court proceeded to categorise 3[three] different situations in which the petitioners would fall depending upon 3[three] broad categories. The three categories are as such:

[i] Category-I was of those teachers who were previously selected and appointed on a particular post which was set aside by the Court in **Tanmoy Nath** (*supra*) and had through fresh selection process being selected and appointed on the same post.

[ii] Category-II comprises of such teachers whose appointments were also set aside but in the fresh selection process they were appointed to a post higher than the one which they previously held.

[iii] Category-III was of those teachers who after being terminated pursuant to **Tanmoy Nath** (*supra*) were appointed on a post lower than they previously held.

[7] The learned Court discussed the variance in the situation of these three categories and devised a principle as to how the benefit of past services as contemplated in Para-125 of **Tanmoy Nath** (*supra*) would be conferred on them. Para-30 of the judgment in **Sangita Reang & others** (*supra*) is extracted hereunder:

**“30. Under the circumstances, petitions are disposed of with following directions:**

**(i) In case of Category-I cases, the petitioners shall receive full benefit of the past service for the purpose of seniority, pension and all other purposes.**

**(ii) In Category-II cases, past service rendered by the petitioners will be counted for the purpose of pension, pay fixation and all other purposes except for seniority. In other words, it is provided that the pay of these petitioners would be fixed in their respective posts pursuant to fresh appointments taking into account entire past service rendered by them and bearing in mind the principles contained in F.R.22 of the Fundamental Rules. However, their past service shall not count towards seniority. They would be placed at the bottom of seniority as on the date of their fresh appointments. It is clarified that these directions shall not enable any other teachers in the same cadre or any other cadre to claim upgradation of his/her pay by seeking removal of anomaly or in any other manner.**

**(iii) In Category-III cases, the petitioners' past service would be counted for the limited purpose of retaining their leave credit, provident fund, pension and gratuity and further that they will be placed in the regular scale of pay from the date of their fresh appointment and the pay will be fixed at the minimum of the scale. They would receive all admissible allowances.”**

[8] It is agreed at the Bar that the decision in **Sangita Reang & others** (*supra*) has been complied with and also followed in the later decision of learned Single Judge of this court in the case of **Prasanta Pal vs. State of Tripura and others** [W.P.(C) No.381 of 2020 order dated 06.07.2020]. In the present batch of writ petitions, the petitioners were also amongst those 10323 teachers whose services were terminated. These petitioners claim to have participated in the recruitment exercise to different post of teachers conducted by the Government of Tripura initiated prior to 31<sup>st</sup> March, 2020.

[9] However, it is canvassed on behalf of the writ petitioners that the selection processes were completed in December, 2019 but the actual offer of appointments were issued after 31<sup>st</sup> March, 2020 due to the intervention of Covid-19. In substance, these petitioners were re-employed after their adhoc services were terminated on 31<sup>st</sup> March, 2020. Apart from this broad factual position, it has been pointed out on behalf of the State by the learned Advocate General that one or other of the writ petitioners, such as Smt. Tapati Debbarma in Writ Appeal No.304 of 2021 arising out of W.P.(C) No.617 of 2020 factually did not continue in employment upon adhoc extension granted after 31<sup>st</sup> December, 2017 though she also participated in the fresh selection exercise and she got reemployed in 2018.

[10] In this background, learned Advocate General has submitted that the observations made at Para-125 in **Tanmoy Nath** (*supra*) and as read in the case of **Sangita Reang & others** (*supra*) do not apply in exact terms to the case of the present writ petitioners. The fault lines being (i) that they were re-employed after 31<sup>st</sup> March, 2020 (ii) some of them did not continue in service on adhoc basis after their termination on 31<sup>st</sup> December, 2017 and could not be

stated to be in service till 31<sup>st</sup> March, 2020 (iii) some of these petitioners also did not appear to have submitted technical resignation and permission of the employer to participate in the fresh selection exercise.

[11] It is also submitted by the learned Advocate General that the pleadings in the writ petitions are also sketchy on these factual aspects. As such, the import of the judgment in **Tanmoy Nath** (*supra*) as affirmed by the Apex Court and read further by the learned Writ Court in the case of **Sangita Reang & others** (*supra*) would not apply in the same terms to the case of the present writ petitioner- respondents.

[12] Learned senior counsel appearing for the writ petitioner- respondents have however argued to the contrary. It is their common case that delay in offer of appointment to the writ petitioners on the part of the Government could not be to their disadvantage as they had participated in the fresh selection exercise initiated prior to 31<sup>st</sup> March, 2020. The writ petitioners also had applied for permission before the competent authority. Learned senior counsel for the writ petitioners however also submit that the principles laid down in the case of **Sangita Reang & others** (*supra*) apply to their case as per the three categories devised by the learned court. Learned senior counsel for the writ petitioners are not able to controvert this contention of the State that for availing the benefit of past service, the terminated teachers ought to have continued till 31<sup>st</sup> March, 2020 on adhoc extensions beyond 31<sup>st</sup> December, 2017 as was the situation in the case of **Sangita Reang & others** (*supra*). It is however also pointed out that since the offer of appointment was made after 31<sup>st</sup> March, 2020, the question of offering technical resignation did not arise as their adhoc extensions were already terminated by 31<sup>st</sup> March, 2020. In summary, they



submit that the principles laid down by this Court in the case of **Sangita Reang & others** (*supra*) do apply to the case of the present writ petitioner depending upon either of the three categories in which they fall. Delay in offer of appointment cannot be the basis to defeat the benefit of past service as granted by this Court in the case of **Tanmoy Nath** (*supra*) at Para-125 and read into by the learned Writ Court in the case of **Sangita Reang & others** (*supra*).

On behalf of the writ petitioners, reliance is also placed on a Division Bench decision of this Court in the case of **Babul Debnath and others vs. State of Tripura and others**, rendered on 21<sup>st</sup> January, 2019 in W.P.(C) No.435 of 2018 & others, that the ratio contained in Para-125 of **Tanmoy Nath** (*supra*) have been reiterated therein.

[13] Bereft of details of the individual writ petitioners the broad contours of the present matters have been outlined in the foregoing paragraphs of this judgment. The issue which falls for consideration in the present batch of appeals and writ petition is whether such teachers whose services were terminated by the judgment of this Court in **Tanmoy Nath** (*supra*) could be entitled to the benefit of their past services as provided at Para-125 of the decision in **Tanmoy Nath** (*supra*) and in the manner read into by the learned Court in the case of **Sangita Reang & others** (*supra*) or not since these writ petitioners have been reemployed after 31<sup>st</sup> March, 2020 i.e. when the adhoc extension to the services of such terminated teachers came to an end.

[14] We are of the considered view that the distinction between the present set of writ petitioners and that of **Sangita Reang and others** (*supra*) sought to be drawn on behalf of the State-appellants is artificial and cannot be used to deny the benefits conferred by this Court in the case of **Tanmoy Nath**

(*supra*) as affirmed by the Apex Court and dealt with in the case of **Sangita Reang & others** (*supra*).

[15] As noted above, the distinction which is sought to be drawn in the present batch of writ petitions/appeals is on the ground that the writ petitioners herein were re-employed after their services came to an end on 31<sup>st</sup> March, 2020. It is, however, not in dispute that the writ petitioners had participated in the fresh selection exercise which was initiated by the State Government prior to 31<sup>st</sup> March, 2020 and possibly the selection process was over but the offer of appointments were made after 31<sup>st</sup> March, 2020. In the case of **Ajoy Debbarma** (*supra*), the apex court at Para-18 of the judgment made an observation which is profitably quoted hereunder:

**“18. In our view, considering the fact that the very selection and appointments were found to be illegal and invalid, no other advantage can be conferred upon the candidates concerned. It must be noted that the attempt on the part of the State in offering certain alternate employment is not to degrade the teachers but some solace is being offered even in cases where the candidates do not succeed in the selections to the posts of teachers. The candidates, if they are otherwise competent and eligible, will certainly have every opportunity till 31.03.2023 to get selected for the posts of teachers in the State and by way of additional benefit those who are unsuccessful in such attempts may retain the alternate employment. In our view, it does not amount to any degradation.”**

[16] The Apex Court taking note of the fact that the fresh selection exercise may entail sometime made it clear that the candidates who were one of those 10323 teachers and whose services were terminated will have opportunity till 31<sup>st</sup> March, 2023 to get selected for the post of teachers in the State if they are otherwise competent and eligible.

[17] The important rider for availing of such benefit as also observed in the case of **Sangita Reang & others** (*supra*) are twofold (i) that these candidates had continued in employment after 31<sup>st</sup> December, 2017 on adhoc

extensions till 31<sup>st</sup> March, 2020 and (ii) they had applied before the competent authority for participating in the fresh selection exercise. This Court is not required to enter into the scrutiny of claims of individual writ petitioners in these present batch of cases. The cases of individual writ petitioners would be examined by the competent authority under the Government of Tripura in the light of the principles discussed hereinabove. However, if individual writ petitioners satisfy the conditions prescribed hereinabove and also laid down in the case of **Sangita Reang & others** (*supra*), they would be entitled to the benefit of past service devised by the learned Court in the case of **Sangita Reang & others** (*supra*) depending upon which of the three categories they fall.

[18] Having held so, this Court deems it proper to direct the competent authority under the department to scrutinize the case of individual writ petitioners in the light of the principles laid down hereinabove and take a decision within a period of 3[three] months from the date of receipt of the copy of this judgment. Needless to say that the consequential benefits, if any, arising out of such decision shall flow in favour of the individual writ petitioners who satisfy the conditions prescribed hereinabove.

These batch of appeals and writ petition are disposed of in the aforesaid terms.

Pending application (s), if any, also stand disposed of.
