Present Sh. Tajender Singh, Ld. Counsel for complainant alongwith complainant.

Sh. Kushagra Bansal, Ld. Counsel alongwith accused.

Surety Manpreet Kaur in person.

Ld. Counsel for accused submits that the offence is bailable in nature. He further submits that 52 connected matters are pending between the parties and accused had furnished bail bonds in some of the connected matters. He has submitted that accused is unable to arrange different sureties and solvency proof in all the connected matters. Ld. Counsel for accused has requested that the same surety be considered in all the connected matters. It is further submitted that accused has already furnished SBP in the sum of Rs.90,000/- in some of the cases and today Original RC of vehicle has been furnished.

Bail bond have already been filed on behalf of accused in CC No. 6761/17, 8228/17, 10071/17, 11630/17, 12724/17, 12855/17 (original SBP filed in CC No. 12855/17) and personal bond have already been accepted in CC No. 13168/2018, 14929/18, 2544/19, 3792/19, 8246/19 and 12713/19.

Considering the overall facts and circumstances, accused is admitted to bail upon furnishing bail bonds in the sum of Rs. 7,00,000/- and surety bond in the like amount. (consolidated bail amount in all the connected matters). Accused has furnished bail bonds in sum of Rs.7,00,000/-. Surety has produced the RC of her car bearing no. DL-7CM-7679. Same is retained on record. Necessary rodkar be issued. *(Original bail bond is kept in CC No. 612/21 and copies have been filed*

in the connected matters).

Ld. Counsel for complainant submits that he has received the copy of reply filed by the accused.

Ld. Counsel for complainant has filed the details of pending cost and stated that amount of Rs.54,000/- is pending to be paid by the accused.

Ld. Counsel for accused submits that cost has been paid to the previous counsel namely Ms. Sahiba Singh and Sh. Yash Chaturvedi and has requested that they be summoned by the court.

Ld. Counsel for complainant submits that the cost of Rs.54,000/- is pending and the previous counsel be called for clarification regarding the same.

Issue Court Notice to the previous counsels for accused, as per the vakalatnama filed on record.
