Kaur, West : Road 25 ft., North : Plot No. 93 of Surinder Pal, Kulwant Rai sons of Des Raj, South : Agriculture land of others, Khasra No. 464 min, area situated at Sultanwind Sub-urban Mahal, Tehsil and District Amritsar, without adopting in due course of law till the date fixed.

Compliance of the order 39 Rule 1 and 2 CPC be made immediately. It is made clear that in case of non-compliance, exparte stay of the plaintiff would be vacated automatically. Let, notice of suit and the stay application be served upon the defendant through ordinary process as well as registered post for 19.12.2018 on filing PF/RC/Ads etc. Plaintiff is directed to furnish draft summons of the defendant with verified particular and copies of plaint and the stay application. Dasti summons for the service of the defendant be given, if so desired.
